



## Life in Australia – Australian values

The Australian Government encourages people to gain an understanding of Australia, its people and their way of life, before applying for a visa to live in Australia.

This includes understanding that the English language, as the national language, is an important unifying element of Australian society. Australian society is also united through the following shared values:

- respect for the freedom and dignity of the individual;
- freedom of religion;
- commitment to the rule of law;
- Parliamentary democracy;
- equality of men and women;
- a spirit of egalitarianism that embraces mutual respect, tolerance, fair play and compassion for those in need and pursuit of the public good;
- equality of opportunity for individuals, regardless of their race, religion or ethnic background.

The *Life in Australia* booklet provides more information on the values that Australians share and their way of life. This booklet is available in a wide range of languages. If you have not already received a copy then it can be obtained from [www.immi.gov.au](http://www.immi.gov.au)

You must have read the *Life in Australia* booklet before completing this application form. If you have difficulty, or are unable to read the booklet, you may have the content of it explained to you, for example, by a friend or relative. This form contains a statement, that you must sign, that confirms you understand and will respect the values of Australian society (as explained in the booklet) and will obey the laws of Australia. This includes acknowledging what would be required if you later applied for Australian citizenship.

This statement must also be signed by each person aged 18 years or over, who is included in this form.

## About this form

Important – Please read this information carefully before you complete your application. Once you have completed your application we strongly advise that you keep a copy for your records.

## Who should use this form?

This form is for use by applicants for a General Skilled Migration (GSM) visa. A summary of the GSM visas has been provided on pages 3–6 of this form. Further information about each visa, including application requirements, is available on the Department of Immigration and Citizenship (the department) website [www.immi.gov.au/skilled/](http://www.immi.gov.au/skilled/)

If the visa subclass that you wish to apply for is NOT listed in pages 3–6 do not complete this form and check the department's website [www.immi.gov.au](http://www.immi.gov.au) for more information. Alternatively, you can contact the nearest office of the department in Australia or the nearest overseas Australian mission. Contact details are available on the website.

## Integrity of application

The department is committed to maintaining the integrity of the visa and citizenship programs. Please be aware that if you or a third party acting on your behalf provide false or misleading information or bogus documents either knowingly or otherwise your visa application will be refused or any visa granted may be cancelled.

## Applying online

The department encourages applicants to apply online. **Applications lodged online have quicker processing times.** For information on how to apply online go to the department's website [www.immi.gov.au/e\\_visa/](http://www.immi.gov.au/e_visa/)

If you are applying online for a GSM visa that requires sponsorship then the sponsorship form must also be completed online.

## Applying on this form

Before completing this form, please read carefully the information below and the information on GSM [www.immi.gov.au/skilled/](http://www.immi.gov.au/skilled/)

The GSM visas are divided into 2 categories: **onshore and offshore.**

You can only apply for an 'onshore' GSM visa while you are in Australia, and you can only be granted an 'onshore' visa while you are in Australia.

Applications for an 'offshore' GSM visa are usually made from outside of Australia, however, you may make an 'offshore' visa application while in Australia provided the conditions attached to your current visa do not prevent you from doing so.

Applicants for an 'offshore' visa should be aware that it is a requirement of these visas that the applicants be outside of Australia for a visa to be granted. There is one exception to this requirement where the main applicant is a New Zealand citizen and in Australia as a holder of a Special Category (subclass 444) visa. In this case you may be inside or outside of Australia at the time your visa is granted.

## Students and General Skilled Migration

Australia has a well-deserved reputation for high-quality education and training. We continue to welcome overseas students, and appreciate the contribution they make to both academic life and the communities in which they live.

People who wish to study in Australia may be granted a Student visa that entitles them to come to Australia on a temporary basis for a specified period to undertake study at an Australian educational institution. While many overseas students make a decision to apply for permanent residence upon completing their studies, this is an entirely **separate process** and there is no guarantee that, on the basis of having held a student visa, a person will meet the requirements to be granted permanent residence.

It is important to note that student visas are aimed at achieving an educational outcome. General Skilled Migration (GSM) on the other hand is predominantly driven by the labour market needs of Australia.

The criteria for grant of GSM visas can change in response to the changing economic circumstances of Australia. All applicants seeking to be granted a permanent GSM visa must meet the relevant criteria set out in the Migration legislation, regardless of whether or not they have previously been in Australia.

It is important for student visa holders to note that any changes to the criteria for the grant of a GSM visa would not affect their Student visa conditions.

Students **should not** make educational choices solely on the basis of a hoping to achieve a particular migration outcome, as the GSM program will continue to change and adapt to Australia's economic needs.

## Visa Application Charge

A GSM visa application is subject to a charge. To check the Visa Application Charge, see form 990i *Charges* available from the department's website [www.immi.gov.au/allforms/990i.htm](http://www.immi.gov.au/allforms/990i.htm) or contact the nearest office of the department in Australia or the nearest overseas Australian mission.

Fees may be subject to adjustment at any time. Visa Application Charges may be subject to adjustment on 1 July each year. This may increase the cost of a visa

Payment **must** accompany your application. If you intend to pay by credit card, please provide details in **Part P**.

## Method of payment

To make a payment, please pay by credit card, debit card, bank cheque or money order made payable to the Department of Immigration and Citizenship. Debit card and credit card are the preferred methods of payment.

An alternate option is to make a payment at the nearest office of the department, if you are in Australia, or the nearest overseas Australian mission, if you are outside Australia. If you choose to pay in this way you must attach the departmental copy of the receipt to your application form as evidence of payment.

You **must** lodge your application with the Adelaide Skilled Processing Centre (ASPC), but you can make a payment at the nearest office of the department in Australia or the nearest overseas Australian mission.

## Making a valid application and supporting documents

To make a valid application you must provide certain supporting documents with your application. The documents required are different for each type of application. If you do not provide the required documents your application may not be valid and may be returned to you.

You will find the **checklists** of the documents you must provide in support of your application on the department's website [www.immi.gov.au/skilled/](http://www.immi.gov.au/skilled/)

You must complete the appropriate checklist from this website if you are sending your application by mail or courier. If you are applying online, the electronic form has an in-built checklist.

In either case, enclose/attach copies of all documents listed on the relevant checklist with your application.

You may be asked to provide other documents during processing. 'Certified copies' of documents means authorised or stamped true copies of originals by a person or agency recognised by law of your country. In Australia, they must be certified by a Justice of the Peace or Commissioner for Declarations or by a person before whom a statutory declaration may be made. The department also accepts documents certified by a registered migration agent.

Documents in languages other than English should be accompanied by an English translation. If the applicant is onshore, the translation should be undertaken by a translator accredited by the National Accreditation Authority for Translators and Interpreters (NAATI). Failure to do so may significantly affect the processing of your application. Translations provided by non-accredited translators overseas should be endorsed by the translator with their full name, address, telephone number, and details of their qualifications and experience in the language being translated.

**Note:** You must include **both** a certified copy of the original language document **and** a certified copy of the translated document with your application. Do not supply any original documents with your application, unless you have been asked to do so.

## Who is covered by this form?

The application form covers a primary applicant and, if applicable, secondary applicants.

For information about who can be included in your application as a secondary applicant, see the department's website [www.immi.gov.au/skilled/](http://www.immi.gov.au/skilled/)

If you have a partner, consider which of you is more likely to meet visa requirements before completing the form. The person who meets the age, skill, work experience or study requirements should be the **primary applicant** and complete **Part A About you**.

'**Partner**' means your spouse or de facto partner (including same-sex partners).

## Dependent children

A dependent child may be your or your partner's child or step-child. 'Step-child' means a child of your current partner or a child of your former partner when the child is under 18 years and you have a legal responsibility to care for that child (for example, when your former partner is deceased and you have legal custody of your former partner's child). You will need to provide a certified copy of the overseas or Australian court order in relation to the custody of the child. A child aged 18 years or over is not considered dependent if he or she is married or in a de facto relationship or is engaged to be married. A child aged 18 years or over will not be considered dependent unless you can show that they are wholly or substantially reliant on you for financial support for their basic needs of food, shelter and clothing. You must also show that you have provided that support for a significant period and that the child is more reliant on you than on any other person or source. Unless you can provide evidence of this, they should apply separately. You should also be aware that a child aged 25 years or over will generally not be considered dependent. Children of any age who have a total or partial loss of bodily or mental functions, which stops them earning a living, are regarded as dependent and part of the family unit (whether or not they migrate with you). Give details of such children and whether or not they are in your care.

In all cases you should attach evidence of your child's dependency on you.

## Custody requirements

The department will seek to ensure that allowing a child to migrate is not in contravention of Australia's international obligations in relation to the prevention of child abduction. If your application includes a child under 18 years of age and the child's other parent is not migrating with you or there is any other person who has the legal right to determine where the child can live, you will need to provide a Statutory Declaration from each of them giving permission for the child to migrate. Alternatively, you can provide a certified copy of a valid court order showing that you, or your partner, has the legal right to remove the child from the country.

## Other dependants

You may include other relatives in your application if they are wholly or substantially reliant on you for financial support for their basic needs of food, shelter and clothing and they have been reliant on you for that support for a substantial period. They must also be more reliant on you for support than on any other person or source. A relative may also be considered dependent on you if they are reliant on you for financial support because they have a mental or physical disability which stops them from earning a living to support themselves. Other relatives dependent on you or your partner may include, for example, an aged, unmarried relative.

**A form 47A Details of child or other dependent family member aged 18 years or over must be completed for each dependant aged 18 years or over, whether migrating or not. The dependant may need to provide supporting documents. Form 47A is available from the department's website [www.immi.gov.au/allforms/](http://www.immi.gov.au/allforms/)**

## About the information you give

The department is authorised to collect information provided on this form under Part 2 of the *Migration Act 1958* 'Control of Arrival and Presence of Non-citizens'. The information provided will be used by the department for assessing your eligibility for a visa to travel, enter and remain in Australia. It may also be used for other purposes relating to the administration of the Migration Act, for example, to assist migrants with settling in Australia, to monitor the conduct of migration agents or for ensuring compliance with the Migration Act.

If you come from a country where the government has issued you with a unique identity number for the purpose of confirming your identity you need to enter that identity number and the country that issued the identity number. (An identity number is usually issued on an Identity Card which contains other personal details such as your full name, date of birth, photograph, signature etc. An identity card can also be referred to as a National Identity Card, Smart Identity Card, Citizen Card etc.)

The information provided on this form, including any information on your health, will be used to assess your health for an Australian visa and may be disclosed to the relevant Commonwealth, state and territory health agencies and examining doctor(s).

Form 1071i *Health requirement for permanent entry to Australia* provides additional information on Australia's permanent visa health requirements. Form 1163i *Health requirement for temporary entry to Australia* has information on Australia's temporary visa health requirements. Forms 1071i and 1163i are available at offices of the department or from the department's website [www.immi.gov.au/allforms/](http://www.immi.gov.au/allforms/)

The information you provide might also be disclosed to agencies who are authorised to receive information relating to adoption, border control, business skills, citizenship, education, employment, health assessment, health insurance, health services, law enforcement, payment of pensions and benefits, taxation, review of decisions and regulation of migration agents.

The collection, access, storage, use and disclosure by the department of the information you provide in this form is governed by the *Privacy Act 1988* and, in particular, by the 11 Information Privacy Principles. The information form 993i *Safeguarding your personal information*, available from the department's website, gives details of agencies to which your personal information might be disclosed.

The department is authorised under the *Migration Act 1958*, in certain circumstances, to collect a range of personal identifiers including a facial image, fingerprints and a signature from non-citizens, including from visa applicants. The department requires personal identifiers to assist in assessing your identity. The department is authorised to disclose your personal identifiers and information relating to your name and other relevant biographical data to a number of agencies including law enforcement and health agencies and to other agencies who may need to check your identity with this department. Where the department obtains personal identifiers they will become part of your official record with the department.

The department is involved in international information exchanges with a number of countries, including the United Kingdom, the United States of America, Canada and New Zealand.
